Re: Product SDS

To our valued customers:

This letter is in response to your request for a Safety Data Sheet (SDS).

All Microflex and Ansell branded medical grade and non-medical single use and disposable glove products fall under the definition of 'articles' as described in 29 Code of Federal Regulations 1900.1200(c) as follows:

*Article means a manufactured item other than a fluid or particle: (i) which is formed to a specific shape or design during manufacture; (ii) which has end use function(s) dependent in whole or in part upon its shape or design during end use; and (iii) which under normal conditions of use does not release more than very small quantities, e.g., minute or trace amounts of a hazardous chemical (as determined under paragraph (d) of this section), and does not pose a physical hazard or health risk to employees.*

As such, Microflex and Ansell branded medical grade and non-medical single use and disposable glove products are exempt from requiring an MSDS as described in 29 Code of Federal Regulations 1900.1200(b)(6)(v).
