- Notes to physician** : Treat symptomatically. Contact poison treatment specialist immediately if large quantities have been ingested or inhaled. To the Doctor: This product contains mineral oil. Accidental injection with this oil-based product, even in small quantities, can cause intense swelling which may, for example, result in ischaemic necrosis and the loss of a digit. Expert PROMPT, surgical attention is required and may necessitate early incision and irrigation of the injected area, especially where there is involvement of finger pulp or tendon.
- Specific treatments** : SEEK IMMEDIATE MEDICAL TREATMENT at nearest Hospital Emergency Room even if only a very small amount is injected, as failure to treat may result in the mineral oil adjuvant causing sterile abscess and/or loss of affected finger or thumb. If pain persists for more than 12 hours after medical examination, seek additional medical advice.
